

"Evaluation of Social Policies to Improve The Social Welfare of Neglected Elderly People in Yogyakarta Province

ABSTRACT

The study "Evaluation of Social Policies to Improve The Social Welfare of Neglected Elderly People in Yogyakarta Province " aimed: (1) to determined achievement of the implementation of social policies for neglected elderly people in Yogyakarta Province ; (2) to designed a model of the development of social policy in order to improve the social welfare of neglected elderly people in Yogyakarta Province. The research approach used in this study was a qualitative research descriptive data retrieval technique also done through observation, interviews depth, and documentation. The location of this research was the Special Region of Yogyakarta descriptions of research subjects: (1) BKKBN DIY, (2) Department of Social Services of Yogyakarta Province, (3) Department of Health of Yogyakarta Province, (4) f Department Research and Development Services Ministry of Social Welfare of the Republic of Indonesia, (5) Social Services Centres For Elderly People (BPSTW) Abiyoso and Budi Luhur Yogyakarta, (6) Neglected elderly people who was handled by BPSTW Yogyakarta, (7) Regional Commission for the Elderly DIY, (8) Forum Communications for Elderly People in Yogyakarta Province . Overall, the evaluation of social policy implementation for neglected elderly people did not perform optimally which related aspects of efficiency, promptness in answering the question, and uptake of the scheme to the equalization target. Meanwhile, the results of which tend to be optimal from the implementation of this policy can be seen from the aspect of effectiveness, usefulness, efficiency and responsiveness. This research has been produce a model of social policy development to improve social welfare of neglected elderly people representatively to be implemented in DIY adopt the model of participatory policy which was an elaboration of the model of top-down policy and bottom-up policy by prioritizing the active participation of the community and the target group of the policy. Although this model of participatory policy provided space auxiliaries active participation of state bodies, communities and groups target however its implementation role of the state (government) and the legislature is required to conduct policy advocacy in policy formulation, policy implementation, facilitation of social welfare services, budgeting, monitoring and evaluation. The outputs of this research are: (1) The manuscript of publication to the Journal of Social Welfare Research B2P3KS Yogyakarta; (2) The manuscript dissemination of research results to the national seminar of Scholars Association of the State Administration (ASIAN) 2016; (3) The desaign model of social policy to improve social welfare for neglected elderly people will be given as a policy recommendation to the relevant stakeholders in Yogyakarta.
