FAMILY FINANCIAL MANAGEMENT TRAINING

ABSTRACT

This community service activity aims to provide insight and provision for the ability to manage administration in the family finance sector and provide assistance in managing it in Karimunjawa Village, Jepara, Central Java. The target of service is housewives in Karimunjawa Village, Jepara, Central Java. Problems are solved in three stages of activities, namely preparation, implementation and evaluation.

Preparation is carried out by conducting a preliminary survey to see the conditions in the field regarding the development of skills of housewives. The implementation was carried out by training and mentoring, using the lecture method namely presentation techniques, followed by question and answer discussions and training as a form of application of the form of training that had been given. Activity evaluation is carried out for each stage through collecting data from each stage of the activity. The method used in implementing community service includes lectures, question and answer and discussion, training, and mentoring. This method provides an opportunity for trainees to manage family financial conditions so that they can improve the quality of life in families with good family financial management.

The results of the training activities showed that 90% participants' mothers understood the family financial material. In addition, the planning and management of family finances are understood by 89% of the participants. 71% participants have also been able to practice family financial management accompanied by servants.
